MEMORANDUM FOR THE MINISTER

Response Letter to the Standing Joint Committee for the Scrutiny of Regulations (Sporting Handguns Regulations)

ISSUE

In a letter dated October 5, 2012 (Annex 1), the Standing Joint Committee for the Scrutiny of Regulations (the Joint Committee) asked whether the *Regulations Prescribing Exclusions from Certain Definitions of the Criminal Code (International Sporting Competition Handguns)* SOR/98-465 (the Sporting Handguns Regulations), and the definition of “prohibited firearm” and “prohibited device” in section 84(1) of the *Criminal Code*, will be updated. Your approval is sought for the proposed departmental response for Deputy Minister Pentney’s signature (Annex 2).

BACKGROUND

The Joint Committee addressed their letter to the Deputy Minister of Public Safety, as the Minister of Public Safety has the general lead on firearms policy; however, the proposed response will be from Deputy Minister Pentney as the Sporting Handguns Regulations are made pursuant to subsections 84(1) and 117.15(12) of the *Criminal Code* and therefore fall within your area of responsibility.

The Joint Committee requests that: (1) the schedule to the Sporting Handguns Regulations—which contains the list of handguns that are excluded from the “prohibited handgun” part of the definition of “prohibited firearm” and “prohibited device” in the *Criminal Code* when used in “international sporting competitions governed by the rules of the International Sporting Union”—be updated; and (2) that subsection 84(1) of the *Criminal Code* be amended to reflect the name change of the International Sporting Union to the International Shooting Sport Federation.

The Sporting Handguns Regulations were enacted in 1998 and were last updated in 2000. They are, in fact, outdated. For example, 32 Smith and Wesson Long calibre handguns on the list of exempted firearms are no longer in production; the replacement models for these models are not included on the list; and, out of the 37 firearms that are exempted in the Regulations, a number of 22 short calibre handguns on the list are no longer used in international competitions.

The definitions of "prohibited device" and "prohibited firearm" in subsection 84(1) of the *Criminal Code* exclude certain handguns and barrels that are prescribed by regulation, where the handgun or barrel "is for use in international shooting competitions governed by the rules of the International Shooting Union". The *Regulations Prescribing Exclusions from Certain Definitions of the Criminal Code (International Sporting Competition Handguns)* in turn set out a list, by make, model and calibre, of handguns excluded from the prohibited firearms class, and exclude from the class of prohibited devices barrels which are components or parts of such handguns.

At the outset, I note that while the definitions of "prohibited device" and "prohibited firearm" in subsection 84(1) of the *Criminal Code* refer to the International Shooting Union, the name of this organization was changed to the International Shooting Sport Federation in 1998. The references in the definitions in question are thus obsolete and should be updated.

I also note that the Schedule to the Regulations, which contains the actual list of excluded handguns, has not been amended since 2000. It has been drawn to my attention that a number of the weapons listed in the Schedule are of a calibre no longer used in competitions governed by the rules of the International Shooting Sport Federation. In addition, it is apparently the case that some weapons now

used in competitions governed by the rules of the International Shooting Sport Federation are not listed in the Schedule.

At the time of the making of these Regulations, the accompanying Regulatory Impact Analysis Statement described the purpose of the Regulations as being to ensure that the inclusion of certain handguns and barrels in the prohibited class did not affect the participation of Canadian athletes in international events. It was also stated that the Regulations would provide a flexible instrument that "can be amended from time to time to deal with further developments in these areas in an effective and timely manner". This seems to have proved not to be the case. Will the Regulations be revised and updated in the near future?





In cases where the meaning of phrase "commonly available in Canada" is at issue, it will ultimately be determined by the courts based on an ordinary meaning of the expression and the specific facts of each case. Moreover, the phrase has not attracted litigation and, as such, there is no compelling evidence that any further elaboration is needed. Accordingly, the Department of Justice will not be recommending an amendment to subparagraph 3(1)(a)(i) and paragraph 3(1)(b) in Part 4 of the Regulations.



In a letter to the Committee dated December 2, 2011 (Annex 2), the Department of Justice undertook to recommend to the Minister that the English version of section 5 be amended to more closely align with the French version.

Rejected amendments

The second issue raised by the Committee involves the term “commonly available in Canada” being used as a criterion to distinguish between two cartridge magazine limits for semi-automatic handguns. These are found in section 3, Part 4, of the Schedule to the Regulations. The Committee is of the view that the term is unclear and requires a definition in the Regulations. The third issue is with the term “variant”. The Joint Committee is of the view that the term is vague and that a definition of this term should also be added to the Regulations.

In its response of December 2, 2011, the Department declined to recommend to the Minister of Justice that a definition for “commonly available in Canada” should be added to the Regulations and stated that it was awaiting the outcome of two cases before the Ontario courts before making a recommendation on whether a definition of “variant” should be added to the Regulations. On March 15, 2012, the Joint Committee considered the December 2, 2011, response of the Department of Justice and, in a letter dated March 22, 2012, the Joint Committee rejected the Department’s rationale concerning “variants” and “commonly available in Canada” and requested a response to these two issues. The Department sent a letter to the Joint Committee dated June 20, 2012, indicating that officials would review the issues in depth in the fall of 2012.

I am writing in response to your letter of August 3, 2011, in which you requested a reply to your earlier correspondence inquiring about the status of our work regarding the *Regulations Prescribing Certain Firearms and other Weapons, Components and Parts of Weapons, Accessories, Cartridge Magazines, Ammunition and Projectiles as Prohibited or Restricted* (the "Regulations"). I regret the delay in responding.

I am pleased to report that with regard to section 5 of the Regulations, the Interdepartmental Working Group agrees that an amendment to the English version of section 5 would clarify its meaning and more closely align it with the French version. Accordingly, we have recommended that such an amendment be made at the earliest opportunity.

The Interdepartmental Working Group has revisited the issue of whether an elaboration of the phrase "commonly available in Canada" is necessary, and has concluded that it would not provide additional guidance to the courts. In cases where the meaning of phrase "commonly available in Canada" is at issue, it will ultimately be determined by the courts based on an ordinary meaning of the expression and the specific facts of each case. Moreover, the phrase has not attracted litigation and, as such, there is no compelling evidence that any further elaboration is needed. Accordingly, the Department of Justice will not be recommending an amendment to subparagraph 3(1)(a)(i) and paragraph 3(1)(b) in Part 4 of the Regulations.

In regard to the variant issue, in *R. v. Henderson*, the Ontario Court of Appeal recently confirmed the decision of the Ontario Superior Court of Justice that the decision of the Registrar to refuse to issue a registration certificate for an unnamed variant was reasonable. In addition, there is a case currently being argued before the Ontario Court of Justice that involves a *Charter* challenge to the term "variant" in the Regulations in the context of a criminal prosecution. It is the view of the Interdepartmental Working Group

MEMORANDUM FOR THE MINISTER

Response Letter to the Standing Joint Committee on Scrutiny of Regulations (Sporting Handguns Regulations)

ISSUE

In a letter dated October 5, 2012 (Annex 1), the Standing Joint Committee on Scrutiny of Regulations (the Committee) asked whether the *Regulations Prescribing Exclusions from Certain Definitions of the Criminal Code (International Sporting Competition Handguns)* SOR/98-465 (the Sporting Handguns Regulations) and the definition of "prohibited firearm" and "prohibited device" in section 84(1) of the *Criminal Code* will be updated. Your approval is sought for the proposed departmental response for Deputy Minister Pentney's signature.

BACKGROUND

The Committee addressed their letter to the Deputy Minister of Public Safety, as the Minister of Public Safety has the general lead on firearms policy; however, the proposed response will be from Deputy Minister Pentney as the Sporting Handguns Regulations are made pursuant to subsections 84(1) and 117.15(12) of the *Criminal Code* and therefore fall within your area of responsibility.

The Committee requests that: (1) the schedule to the Sporting Handguns Regulations—which contains the list of handguns that are excluded from the "prohibited handgun" part of the definition of "prohibited firearm" and "prohibited device" in the *Criminal Code* when used in "international sporting competitions governed by the rules of the International Sporting Union"—be updated; and (2) that subsection 84(1) of the *Criminal Code* be amended to reflect the name change of the International Sporting Union to the International Shooting Sport Federation.

The Sporting Handguns Regulations were enacted in 1998 and were last updated in 2000. They are, in fact, outdated. For example, 32 Smith and Wesson Long calibre handguns on the list of exempted firearms are no longer in production; the replacement models for these models are not included on the list; and, out of the 37 firearms that are exempted in the Regulations, a number of 22 short calibre handguns on the list are no longer used in international competitions.

The definitions of "prohibited device" and "prohibited firearm" in subsection 84(1) of the *Criminal Code* exclude certain handguns and barrels that are prescribed by regulation, where the handgun or barrel "is for use in international shooting competitions governed by the rules of the International Shooting Union". The *Regulations Prescribing Exclusions from Certain Definitions of the Criminal Code (International Sporting Competition Handguns)* in turn set out a list, by make, model and calibre, of handguns excluded from the prohibited firearms class, and exclude from the class of prohibited devices barrels which are components or parts of such handguns.

At the outset, I note that while the definitions of "prohibited device" and "prohibited firearm" in subsection 84(1) of the *Criminal Code* refer to the International Shooting Union, the name of this organization was changed to the International Shooting Sport Federation in 1998. The references in the definitions in question are thus obsolete and should be updated.

I also note that the Schedule to the Regulations, which contains the actual list of excluded handguns, has not been amended since 2000. It has been drawn to my attention that a number of the weapons listed in the Schedule are of a calibre no longer used in competitions governed by the rules of the International Shooting Sport Federation. In addition, it is apparently the case that some weapons now



used in competitions governed by the rules of the International Shooting Sport Federation are not listed in the Schedule.

At the time of the making of these Regulations, the accompanying Regulatory Impact Analysis Statement described the purpose of the Regulations as being to ensure that the inclusion of certain handguns and barrels in the prohibited class did not affect the participation of Canadian athletes in international events. It was also stated that the Regulations would provide a flexible instrument that "can be amended from time to time to deal with further developments in these areas in an effective and timely manner". This seems to have proved not to be the case. Will the Regulations be revised and updated in the near future?
