

## **BRAD TROST, 100% CONSERVATIVE**

As well as a staunch opponent of C-68, Brad Trost stands for family-friendly, child-friendly and senior-friendly policy.

A geophysicist, Brad opposes the notion of man-made climate change. As Prime Minister, he will declare an end to the war on oil & gas & coal--no carbon tax, carbon pricing or "cap & trade." Brad will bring a Parental Bill of Rights for child-rearing and education, legislate protection for pre-born victims of crime and a ban on gender-selection abortion, and block immigration from countries that support terrorism or Islamic extremism.

First elected in June, 2004, Brad is currently the Member of Parliament for Saskatoon-University, an urban riding in central Saskatchewan at the heart of which is situated the University of Saskatchewan campus.

Prior to his election, Brad worked as an exploration geophysicist (prospector), having graduated from the University of Saskatchewan with bachelor degrees in geophysics and economics. He also participated in his family's mixed grain, oilseeds and beef cattle farm operation.

Brad's parliamentary and legislative experience is extensive, particularly on issues relating to energy, mining and agriculture. Brad introduced legislation to open up Canada's uranium sector to foreign investment. He founded the Conservative Party's Energy Caucus and has served as a member of the House of Commons Standing Committee on Natural Resources for the past ten years. He has also served on both the Standing Committee on International Trade and the Standing Committee on Industry. He was elected vice-chair of the Canada-U.S. Parliamentary Association. Prior to declaring as a candidate, Brad was the Conservative Official Opposition Critic on Canada-U.S. Relations.

### AN OPEN LETTER TO RESPONSIBLE, LAW-ABIDING FIREARMS OWNERS

#### Dear Friends,

Thirty years of ineffective Liberal firearms legislation have proved that **law-abiding gun owners aren't responsible for violent crime.** They never have been.

As Caillin Langmann argued, <u>there was no benefit from firearms legislation</u> and firearm homicide from 1974 to 2008.<sup>i</sup> Gary Mauser showed: "There is no convincing empirical research supporting the proposition that restricting general civilian access to firearms acts to reduce homicide rates." <sup>ii</sup> Mauser also argued that <u>Canadians who have a firearms licence are less than one-third</u> as likely to commit murder as other <u>Canadians</u>. Statistics Canada data show that licensed gun owners have a homicide rate of 0.60 per 100,000 licensed gun owners

between 1997 and 2010. Over the same period, the national homicide rate averaged 1.85 per 100,000.<sup>iii</sup>

# What a waste of billions of your tax dollars! It also proves the point Reform Party Members of Parliament warned everyone about in 1994 and 1995.

As with my development of a sensible, responsible firearms policy for my campaign, <u>I will consult or mandate the</u> responsible minister to consult with responsible gun owners in Canada before drafting legislation to be tabled or regulations to be attached to legislation.

### "Repeal Bill C-68"


As Leader of the federal Conservative Party and Leader of the Opposition, I will PUSH for the following. As Prime Minister, in my first mandate I will:

- 1. Repeal Bill C-68, returning Canada to the effective gun control regime that existed in 1994;
- 2. <u>Convert all existing Possession and Acquisition Licences</u> to the more effective Firearms Acquisition Certificate (FAC);
- 3. Empower valid FACs to provide the holders with a comprehensive Canada-wide Authorization to Transport;
- 4. Create a <u>Prohibited List of those persons Too Dangerous to Own Firearms</u> requiring mandatory reporting of change of addresses for those convicted violent criminals on this list;
- 5. <u>Relax Authorization to Carry Procedures</u> so off-duty police officers can carry firearms;
- 6. <u>Allow licensed gun owners of prohibited firearms to take once again to federal-approved firearms ranges;</u> and
- 7. <u>Make the destruction of all seized firearms optional for municipalities and police services</u> so seized firearms can be auctioned to holders of valid FACs and authorized firearms dealers.

Further, **I believe in everyone's fundamental right to own and enjoy property.** The government doesn't have the right to force Canadians (under threat of criminal prosecution and spending years in jail) to buy a licence for the simple possession of a firearm or 100 firearms. **The government has the right to regulate the acquisition and use of firearms, but NOT simple possession.** In the long term, it makes far more sense for both public and police safety (as my item '4,' above indicates) **to keep track of a few hundred thousand convicted violent criminals** rather than two million law-abiding gun owners. Therefore, I will:

- 1. <u>Remove prohibitions</u> on magazines and "small" handguns and "dangerous" calibre [25 and 32];
- 2. <u>Put the Cabinet back in charge</u> of deciding any future prohibitions;
- 3. <u>Give the RCMP a time limit</u> to screen and classify imported arms;
- 4. <u>Only support prohibitions on full-auto</u> by design and original manufacture not "could be made to"; and
- 5. <u>Rescind and reject limits on the number of firearms or quantity of ammunition</u> someone can own or purchase in any given time period.
