BAIL DENIED FOR ALLEGED CHILLIWACK FIREARM THIEF CONVICTED OF SIMILAR CRIME IN

ALBERTA - Andrew Scott Charpentier was arrested in June in connection with a break-and-enter at a property in Lindell Beach on May 23 during which two safes were stolen, one full of firearms. Police were tipped off to Charpentier's alleged connection to the firearms theft after his girlfriend called police to report a domestic assault. Addressing the secondary grounds for detention, Crown counsel Paul Blessin pointed to the conviction in Alberta after which **he was banned from possessing firearms for life**, and to the fact that twice he was recently convicted of driving while prohibited despite the fact that he does not have a driver's licence. REGISTRATIONS OF RESTRICTED FIREARM ON THE RISE IN MANITOBA

SEVEN thousand more restricted firearms have been legally registered in Manitoba in the last four years and experts on both sides of the issue suggest it could be due to the popularity of shooting sports or as a reaction to possible bans. There were just under 30,000 restricted firearms (mainly handguns, but the category also includes some rifles such as AR-15s) registered in Manitoba in 2015. By last year, it was 37,000. Restricted firearm ownership is on the rise nationally as well.

EXCERPT #1: Gun enthusiasts say it's because shooting sports are attracting more people. "These are sports that are really on the rise," said Tracey Wilson of the Canadian Coalition for Firearm Rights, adding it's inclusive for all bodies. At her home range, there are shooters who use wheelchairs, others up to 65. Wilson said for smaller people, handguns are easier to use than a long gun.

EXCERPT #2: "With more guns in circulation, there is a greater probability of those firearms finding their way into the wrong people's hands, and that could be an indicator for why there has been an uptick in shootings in many of the major cities across Canada," said University of Toronto sociology professor Jooyoung Lee. While for decades most crime guns have come from the United States, in recent years some studies have suggested more are coming from within Canada. Lee said there's not enough data to know which is right. "We have very select data that paints these two vastly different pictures, which in turn would demand ... vastly different policy interventions. And yet we don't know," he said.

EXCERPT #1: That sentiment was echoed by Tracey Wilson of the firearms advocacy group, Canadian Coalition for Firearms Rights (CCFR) who said of the Liberal revamped FCAC, "I think this was a missed opportunity for the Liberals to have real advisors on a very complex problem. It appears that most of the appointments were more or less appeasements and none of them were really consulted when crafting policy. This is clear evidence that the Liberals didn't plan to do what's best for public safety, but rather use the members of CFAC to hide behind with their hurried and sloppy legislation".

EXCERPT #2: Tony Bernardo of the firearms advocacy group Canadian Shooting Sports Association was a former member of the committee before it was revamped in by the new Liberal government. He said the committee was originally created to provide advice, not direction, to the government. Of the resignation of Ms Provost he said, it would appear she misunderstood the role, adding the resignation seemed be an "indication her interest in the committee was to push the gun-ban agenda she has advocated for so many years, not to provide clarity to the Minister's decision-making process"

GUN CONTROL ADVOCATE CHALLENGES GOVERNMENT CLAIMS OVER FIREARM

CONSULTATIONS - "That's not true," Provost told iPolitics in a phone interview Wednesday. "I can assure you we never examined the C-71 bill before it was tabled." Provost said the committee members only took part in a conference call on March 19, the day before Goodale tabled the legislation. RCMP CONSTABLE CHARGED AFTER GUN, AMMO STOLEN FROM UNMARKED VEHICLE AT SASKATOON PARKADE - Following the Saskatoon police investigation into the circumstances surrounding the storage of the gun, a charge was laid against the constable. RCMP Constable Shannon Drall was charged with Unsafe Storage of a Restricted Firearm contravening Section 6 of the Storage, Display, Transportation and Handling of Firearms by Individuals Regulations, contrary to Section 86(2) of the Canadian Criminal Code. According to RCMP on Wednesday, the “officer responsible for the firearm was placed on administrative duties and an internal RCMP Code of Conduct investigation was initiated. As a result of the conduct investigation, corrective measures were imposed on the officer,” who has since returned to operational duties. FORMER GUN PANEL CHAIR JACK MAJOR SAYS COMMITTEE WAS 'AN AFTERTHOUGHT' FOR FEDS - OTTAWA — A former chairman of the federal advisory panel on firearms says he found the committee to be a well-meaning but ultimately pointless exercise because members were not allowed to conduct independent research. Jack Major, a retired Supreme Court judge, said Tuesday he wrote twice to Public Safety Minister Ralph Goodale about the need to hear witnesses and gather facts on gun-related issues, but got no reply to either letter. Conservative public safety critic Pierre Paul-Hus said Tuesday the firearms panel is in chaos. “Their own members are saying the Trudeau Liberals are refusing to listen to witnesses and experts,” he said in a statement. “This proves what Conservatives have been saying all along — the Liberals’ approach to firearms is based solely around politics and not evidence.

SHOOTING SURVIVOR QUILTS PANEL OVER 'TIMID' LIBERAL RECORD ON ASSAULT-STYLE GUNS

OTTAWA -- Mass-shooting survivor Nathalie Provost has quit the federal firearms advisory committee in frustration, saying she is "extremely disappointed" with the Liberal government's failure to crack down on assault-style rifles. Provost says she saw the appointment as an opportunity to take concrete action to improve public safety. But she was surprised in early 2018 when Goodale introduced Bill C-71 "without any discussion" with the advisory committee, putting members in a difficult position. NATIONAL POST - STRICTER GUN LAWS TIED TO FEWER CHILDHOOD GUN DEATHS

Firearm injuries are the second leading cause of death among American children, but most studies of policies to prevent fatal shootings haven't focused specifically on kids, researchers note in Pediatrics. For the current study, researchers examined data on children under age 21 who were killed by firearms to see how state regulations – including background

checks for gun purchases, restrictions on carrying guns in public places and enhanced child and consumer safety policies – might influence the odds of fatal shootings. States could receive a maximum score of 100 for the strictest gun laws. State gun law scores ranged from -39 to 81, and gun ownership ranged from 5.2% to 61.7% across states. Every 10-point increase in state scores for stricter gun laws was associated with 4% lower rates of firearm-related child mortality, the study found. CBC - 'FIND THEM ALL AND JUST BURN THEM': THE FIGHT AGAINST ILLEGAL GUNS IN N.S.

Police in Nova Scotia seized more than 2,000 guns over 2 years. The most frequent types were rifles (1,136), shotguns (720) and handguns (251). One machine gun was also seized, along with two submachine guns, according to data from Halifax Regional Police. The weapons are particularly dangerous because of their high rate of fire. One of the submachine guns was stolen and then recovered by police, while the other two guns were handed to police by people who didn't want them anymore. A third of the 340 guns collected by Halifax police were turned over to officers voluntarily by people looking to get rid of them. Seventy-four firearms were taken from suspects charged with things like assault, assault with a weapon, robbery, forcible confinement, illegal possession of a weapon and theft. "Certainly it's very concerning to us and it should be to the public," said MacLeod. Police also confiscated 79 weapons that weren't stored safely. Another 21 guns were found by officers while they conducted their duties. The remaining 58 guns were collected for a variety of reasons, including from people in mental-health distress, from people not authorized to have a firearm, from people uttering threats, and by police acting on warrants. TOUGHER LAW ON WEAPONS TO ENSURE PUNISHMENT IN BAHRAIN

The 1976 Explosives, Weapons and Ammunition Law has already been amended twice. Under the law, anyone found carrying weapons, even if licensed, into worship places, public transport or to any public gathering faces no less than five years in jail and a fine of no less than BD500. The punishment for possession, manufacture, smuggling and distribution is no less than seven years in jail and a fine of between BD300 and BD2,000. Illegal weapons trade is punishable with three years in jail and fines of up to BD500, while those violating the conditions of a weapons licence could be jailed for up to three years and fined up to BD200. Misuse of licensed weapons or firecrackers during celebrations, weddings or gatherings attract jail time of between two to five years and a fine of between BD50 and BD200. Committee vice-chairman Bader Al Dossary said the law should be applied to all equally. "Whether it is an MP or anyone else misusing weapons, licensed or not, he should be jailed for 15 years," he said. STUDY: 'IDEOLOGICALLY DRIVEN' WIND FARMS THREATEN BIRDS W/ EXTINCTION

Environmental researchers and bird experts contribute to "The Impact of Wind Energy on Wildlife and the Environment." Peter Henderson, a University of Oxford senior research associate, described the harmful impact that wind turbines have on bats, GWPF reported. "About 200,000 bats are annually killed at onshore wind turbines in Germany alone," Henderson said. "These numbers are sufficient to produce concern for future populations, as bats are long-lived and reproduce slowly, so cannot quickly replace such losses." Klaus Richarz, who operated State Bird Sanctuaries in Germany, said wind turbines companies are not obeying environmental guidelines, harming birdlife. Richarz said wind turbines affect birds in two main ways. Wind turbines disturb birds' natural habitats with noise, causing disruption in their breeding and migration habits, and they pose an "increased risk of collision." Oliver Krüger, a professor of animal behavior at Germany's University of Bielefeld, said in the report that wind turbines threaten birds of prey and ducks.
