# NEW ZEALAND'S PM ARDERN ACTS TO TIGHTEN GUN LAWS FURTHER, SIX MONTHS AFTER

ATTACK - WELLINGTON — New Zealand's Prime Minister Jacinda Ardern introduced a new bill to parliament on Friday that aims to further tighten gun laws. "Owning a firearm is a privilege not a right," Ardern said in a statement announcing the new bill on Friday. "That attack exposed weaknesses in legislation which we have the power to fix. We would not be a responsible government if we didn't address them," she said. The new bill, details of which have already been made public and that will have its first reading on Sept. 24, will include the creation of a registry to monitor and track every firearm legally held in New Zealand. It also tightens other rules for gun dealers and for individuals to get and keep a firearm license. License renewal for individuals was also reduced to five years from ten years. # TRAFFICKING TRIAL HEARS IT'S 'REALLY EASY TO BUY GUNS ... REALLY CHEAP' IN WINDSOR

The last trial connected to Project Kirby, which saw 10 people charged with 111 offences after raids and arrests were simultaneously carried out in Windsor, Lakeshore and London, began Wednesday in Superior Court in Windsor. The year-long operation netted eight illegal guns, two kilograms of cocaine, C\$67,000 and US\$10,500 in cash and three seized vehicles. Curtis Elliott, 33, is charged with 30 conspiracy, firearms, gun trafficking and other offences. The first witness at a trial expected to last four weeks painted a disturbing picture of the Windsor drugs and guns scene. "Guns are really easy to buy here, and really cheap — that's the fact," said Mark Dobrowski, who, before becoming a paid covert police agent, was himself deeply involved in Windsor's drugs and firearms trade.

Waterloo Regional Police Service, Chief Bryan Larkin says, "I do not believe, and I do not think, that our region and our police service is getting its fair share of provincial funding. He made the comments Friday during a press conference for Project Piece, a four-month investigation into drugs and violent crime in Cambridge. The investigation resulted in 30 arrests and 115 charges, as well as the seizure of weapons, \$140,000 worth of drugs as well as fake and real money. **ABSTRACT:** Hundreds of millions of dollars go to firearms research on crime, suicides, and accidental deaths, but the vast majority of the money, particularly government money, is being spent on public health research. We got a response rate of over 43%, or 120, from the 277 researchers we approached, and we found large statistically significant differences in the views of academic researchers in criminology, economics, and public health on 33 different gun control policies for both mass public shootings and murder will reduce crime and save lives. Our sample is much larger than two surveys of 32 researchers by the New York Times as well as larger than surveys done by others. While none of our groups are quite as supportive of gun control as reported by the Times, public health researchers come closest. We find that Economists and to a lesser extent criminologists rank order the efficacy of gun control policies in the opposite order that public health researcher do. If one believes that any group of the experts have properly ranked the effectiveness of different gun control regulations, registered voters have essentially ordered the effectiveness of regulations entirely randomly.

#### VISITING CANADA? LEAVE YOUR FIREARMS AT HOME

OTTAWA, Sept. 6, 2019 /CNW/ - The Canada Border Services Agency (CBSA) is launching a firearms awareness campaign reminding visitors to Canada about Canadian firearm laws. Canadian laws are different than those in the United States - the CBSA suggests you check its requirements and restrictions before arriving at a Canadian port of entry. For

visitors to Canada, we strongly recommend that you leave your firearm at home when travelling to Canada and/or transiting through to reach another US destination. Additionally, you must have all necessary permits and ensure your firearm(s) is stored and transported appropriately. Canadian firearm laws are clear – you must declare any firearm to the CBSA. Additionally, you must have all necessary permits and ensure your firearm(s) is stored and transported appropriately. Failure to declare your firearms may lead to seizure, criminal charges and may make you inadmissible to Canada. We look forward to your visit to Canada and take this opportunity to remind you to declare all goods with you. ### RULES FOR BRINGING A FIREARM INTO THE U.S. BRINGING FIREARMS ACROSS THE BORDER

**INTO THE UNITED STATES.** The United States is very strict about the regulations you must follow to bring a firearm into the country. Be sure to read our page on transporting firearms across the border for additional information that applies to both countries. Generally speaking, it is unlawful for non-U.S. residents to possess or obtain firearms or ammunition while in the U.S. The most common exception to this is when entering the country to hunt or for a shooting competition. The U.S. allows more types of weapons across the border than Canada does, and U.S. border agents typically have more discretion about their response if you break those rules. Certainly you can still be fined, or even jailed, if you fail to declare a weapon. #### RED FLAG LAW PROPOSALS RAISE STAKES IN GUN REFORM DEBATE

The latest debate on gun control has raised red flags on both sides of the political aisle. Late Tuesday evening, the House Judiciary Committee passed three bills aimed at quelling the epidemic of gun violence in the United States. Among the bills was a national version of a mandate of extreme risk protection orders (ERPOs), which already is being used in 13 states. Also known as "red flag" laws, ERPOs allow local authorities or family members to take away weapons, through a court order, from any individual who is a potential threat toward themselves or others. While the law was passed by Congress, it will likely stall on the Senate floor. The proposals have ignited a debate about whether red flags laws are effective. #### POLLS SHOW GUN CONTROL SUPPORT TRENDING DOWN

# SWEEPING SURVEY ON GUNS SHOWS LARGE SWATHS OF AGREEMENT, EXCEPT IN ONE AREA

Research published Monday in the journal Health Affairs shows that the ideological split on open-carry policies is in line with national trends, but that gun owners and non-gun owners are in large agreement on other matters, like background checks and licensing. Both segments also agreed to temporary gun removal by police if a person is a risk to themselves or others. Statistically, gun owners are more supportive than non-gun owners of concealed-carry on college campuses, school grounds, and in public without a license. But that doesn't mean there isn't some common ground in the concealed carry debate: The John Hopkins researchers also found that both gun owners and non-gun owners supported the requirement of safety training when applying for a concealed carry license. Overall, 73 percent of gun owners said they would support that requirement, while 83 percent of non-gun owners reported the same.
