#### WHAT BERMUDA'S 50-YEAR-OLD GUN BAN CAN TEACH CANADA

In the early 1970s, a spate of high-profile murders in Bermuda – including the assassination of the governor – prompted the government to confiscate firearms, resulting in one of the world's strictest gun regimes. Today, only certain members of the Bermuda Police Service are authorized to use handguns; all others must receive authorization from the police commissioner, and that's usually reserved for the military. Members of licensed rifle clubs may possess firearms with a licence that must be renewed annually, and Bermudians cannot keep ammunition at home. # NENSHI NON-COMMITTAL ON LIBERAL PITCH FOR MUNICIPAL HANDGUN BAN

Calgary police Chief Mark Neufeld, meanwhile, says he isn't sold on a handgun ban fixing any issues when it comes to violence on the streets of Calgary. "I think our position, through the Canadian Association of Chiefs of Police, has been that the gun laws in Canada are already quite stringent," he said. "When we look at the shooting we have on the streets, these are not lawful gun owners out there committing crimes. "Guns are either stolen or smuggled in from another country but they're illegal guns already. Our position thus far has been that we should be looking in other areas: things like bail provisions, and minimum sentencing and these kinds of things." Neufeld also sees gun storage as an issue that needs to be addressed. "There's a lot of guns that end up falling into criminals hands as a result of break-ins in communities, both rural and urban," he added. # RCMP TO PICK WHICH GUNS TO CONFISCATE UNDER TRUDEAU, CTV REPORTS

TheGunBlog.ca — The RCMP will decide which guns to confiscate from hunters, farmers and sport shooters if Justin Trudeau is re-elected prime minister of Canada next month, CTV News reported, citing Trudeau's Liberal Party. The Ottawa-based Royal Canadian Mounted Police gives its opinion on the legal class of firearms based on its interpretation of the law. The government decides the law and can arbitrarily prohibit any model of firearm at any time. # GUN LOBBYIST BRUSHES OFF LIBERAL COMPLAINT OVER ELECTION ADS

One of Canada's leading sport shooting lobby groups says it is "in the process" of registering as a third party with Elections Canada after the Liberal party filed a complaint claiming the association has contravened elections act rules for third-party advertising. The Liberal candidate for the downtown Toronto electoral district of Spadina-Fort York made public Wednesday a complaint to the Commissioner of Canada Elections calling for an investigation into ads the Canadian Shooting Sports Association sent out in response to a sweeping Liberal gun-control platform Justin Trudeau unveiled in Toronto last week. #### LIBERALS ALLEGE GUN GROUP'S ELECTION ADS BREAK LAW, ASK FOR INVESTIGATION

OTTAWA — The Liberals have filed a complaint about advertising by the Canadian Shooting Sports Association during the federal election campaign. Liberal candidate Adam Vaughan wrote Wednesday to elections commissioner Yves Cote, asking that he investigate nine online videos, produced by the association in English and Mandarin, urging gun owners to vote and warning that their right to own firearms is at stake. Any advocacy group that spends more than \$500 on political activity during the campaign is required to register as a third party with Elections Canada, which comes with obligations to disclose details about where its money comes from and how it's being used. As of Wednesday, the Canadian Shooting Sports Association was not registered, although Vaughan said it would appear to have incurred expenses exceeding \$500. Moreover, he said the videos do not include the legally required tag line identifying who authorized them. # TRUTH TRACKER: WHAT DOES THE LIBERALS' GUN BAN REALLY INVOLVE?

As expected, Justin Trudeau's Liberals announced a plan last week to ban "all military-style assault rifles, including the AR-15" and to give the power to municipalities to ban handguns. That prompted prominent gun rights advocate Nicolas Johnson, who operates TheGunBlog.ca, to write a post Sept. 20 that led with: "Justin Trudeau promised the biggest instant gun bans against hunters, farmers and sport shooters in Canadian history if he is re-elected prime minister." In a tweet a few days later, @thegunblog wrote: "Trudeau isn't banning assault rifles. He is confiscating hunting and sporting rifles from hundreds of thousands of federally licensed men and women who obey the law, no matter how unjust or immoral. Criminal gangs and terrorists will keep their assault rifles." That's sure to get the attention of gun owners, but it's not accurate, at least not based on what the Liberals have revealed in their campaign promise, says history professor Blake Brown. # STATEMENT BY THE ONTARIO ASSOCIATION OF CHIEFS OF POLICE (OACP) REGARDING THE CONTROL OF FIREARMS IN CANADA AND THE IMPACT OF GUN VIOLENCE ON OUR COMMUNITIES SEPTEMBER 25, 2019

As Ontario's police leaders, we listen carefully to members of all of our communities and work with community leaders and public policymakers on proactive measures to ensure everyone in Ontario can live and work safely in their communities without fear. The OACP also recognizes that many Ontarians are responsible gun owners. Ontario's police leaders support a prohibition on all military-designed assault rifles. In our view, these weapons have no place in our communities and should be reserved for use by Canada's military and law enforcement. In our discussions with public-policy makers at all levels of government, our association has and will continue to raise concerns about handguns crossing the Canadian border from the United States of America. We believe that this is the root source of illegal guns used in the commission of violent crimes. It is an issue that must be addressed by Canadian policy-makers. Part of the solution may be for municipalities to have the ability to augment federal restrictions on handguns. The OACP also believes that our border security partners require more resources, new authorities, offences, and penalties in order to stop the importation of illegal firearms into Canada. We also support new resources for law enforcement organizations to specifically target illegal firearms as well as new offences and penalties for individuals who choose to put our communities at risk by importing, possessing, and using illegal firearms in the commission of a crime. Ontario's police leaders are aware of public concerns about the ability of police services when it comes to tracing firearms that may be associated to criminal activity. We note that some police services in Ontario do keep statistics related to this for investigative purposes and can provide data on such firearms. Police services comply with all Provincial reporting obligations. The OACP supports the Canadian Association of Chiefs of Police's (CACP) Special Purpose Committee that is currently looking at gaps in the data, including a possible new data collection regime. We are in favour of discussions with public-policy makers regarding establishing a national system to support the tracing of firearms, however a system of this nature must come with appropriate funding.

# A SHORT HISTORY OF THE AR-15 IN CANADA

The AR-15 appeared in the Canadian market by the mid to late 1970s. Some Canadians immediately began to express concern about the gun. The Windsor Star, for instance, wrote in 1975 that criminals "might very well show some interest in the high-powered AR-15." The Canadian Association of Chiefs of Police also raised concerns about such firearms, and in 1977 the federal government declared the AR-15 a restricted weapon, meaning that a potential purchaser had to pass a higher threshold to acquire the gun. This move angered some gun groups, who charged that the classification decision was based on the gun's appearance rather than its capability. An advocate for firearm owners, Michael Martinoff, responded by declaring before a parliamentary committee that he would refuse to register his AR-15. The complaints of the gun community led the government of former prime minister Joe Clark to reclassify the AR-15 as a non-restricted firearm.
