**Two million licensed gun owners are required to report their addresses to police but
NOT the more than 443,000 convicted criminals prohibited from owning firearms by the courts!**

ONTARIO COURT IMPOSES PEACE BOND AGAINST FAR-RIGHT FIGURE OVER ONLINE THREATS

Goudreau is also prohibited from possessing any weapons. Peace bonds are similar to restraining orders and allow the courts to impose limitations on peoples' liberties through bail-like conditions. In 2015, the federal government revamped the Criminal Code to lower the standard for obtaining terror-related peace bonds as part of its anti-terror legislation. The RCMP has used these peace bonds in recent years as a counter-terrorism tool against people feared of attempting to join terrorist groups abroad such as the Islamic State.

ELLSON SENTENCED FOR DRUG AND FIREARM CHARGES

Marion Ellson was sentenced Aug. 6 to 11 years in prison on the possession of carfentanil for the purpose of trafficking charge. MAN CHARGED IN CONNECTION WITH MARLBOROUGH SHOOTING

A man has been charged with seven firearm-related offences after a shooting outside a convenience store in Calgary's northeast last week. Ahmed Hassan Rakka is charged with one count each of discharging a firearm with intent to wound, possession of a firearm in

a motor vehicle, possession of a firearm without a licence, possession of a firearm without a registration certificate, possession of a prohibited/restricted firearm with ammunition, **possession of a firearm contrary to a prohibition order and breach of a recognizance order**. BAIL DENIED FOR ALLEGED CHILLIWACK FIREARM THIEF CONVICTED OF SIMILAR CRIME IN ALBERTA -
Andrew Scott Charpentier was arrested in June in connection with a break-and-enter at a property in Lindell Beach on May 23 during which two safes were stolen, one full of firearms. Police were tipped off to Charpentier's alleged connection to the firearms theft after his girlfriend called police to report a domestic assault. Addressing the secondary grounds for detention, Crown counsel Paul Blessin pointed to the conviction in Alberta after which **he was banned from possessing firearms for life**, and to the fact that twice he was recently convicted of driving while prohibited despite the fact that he does not have a driver's licence. TWO PEOPLE FACING 84 CHARGES AFTER GUNS AND GANGS UNIT INVESTIGATION
The investigation was launched June 12 after police were notified that the contents of a package being shipped to a home in Calgary didn't match its description. Shaun Alexander Folk, 42, of Calgary, is charged with 51 offences including:

- Unauthorized possession of a prohibited firearm
- Possession of a firearm knowing it was unauthorized
- Possession of a prohibited firearm with ammunition
- Unsafe storage of a firearm
- **Possession of a firearm while prohibited from doing so**
- **Breaching a recognizance**
- Possession of stolen property over \$5,000
- Fraud
